**PUBLIC NOTICE No. 2 /2020**

SUB: Union Budget 2020-2021 – Instructions reg.

It is brought to the notice of the Trade, Industry and CHA Association, that the Union Budget 2020-2021, is due to be presented in the Parliament on 1<sup>st</sup> Feb 2020. Therefore, the services of filing of EDI Bills of Entry would not be available in Indian Customs EDI System (ICES 1.5) from 20.00 hrs onwards on 1<sup>st</sup> Feb., 2020 till completion of updation of all changes in the ICES 1.5 All other functions at ICES 1.5 would continue as usual. To avoid inconvenience, due to Budget related changes in the notification and other directories, all stake holders are requested to expedite the clearance and take out-of-charge in respect of Bills of Entry, pending in the queue, before directory changes are enabled in the ICES 1.5. Further permission u/s 48 in ICES, will not be permitted by any Assistant Commissioner from 20.00 hrs on 1<sup>st</sup> Feb.,2020.

Further suitable information TICKERS will be made available on CITRIX as well as CBIC and ICEGATE Websites regarding the timing of submission of the regular filing of Bills of Entry and approvals u/s 48. The information of ICEGATE being shut down for filing of Bills of Entry on 1<sup>st</sup> Feb,2020 from 20.00hrs onwards would be flashed on the website at <http://www.icegate.gov.in>.

During the Budget Activity, Shipping Bill filing and processing will continue as usual without any stoppage. If any changes are announced in the Export Duty and Export Cess during the Budget, it is advised that the sites will keep a track of the relevant SBs filed on or after 1<sup>st</sup> Feb 2020 till the directory changes are made online, and export duty/cess be collected manually thereon. Similarly, processing of Bes filed before 20.00hrs on 1<sup>st</sup> Feb 2020 will also continue as usual. However , all other servers at ICEGATE will continue as usual.
