STANDING ORDER NO. 10/2017

Subject: Monitoring of appeal cases, action for early hearing in cases of huge revenue arrears, updation of records and maintenance of database for pre-deposits – reg.

Attention of the Officers / Staff is invited to deal with the significant aspect of work related to the "recovery of arrears of revenue" by giving it a Top Priority. In this regard, the cases with high revenue stakes should be identified and proposed for out of turn early hearing before the Appellate authorities. Similarly, in order to get the interim Stay Orders vacated, proposals should be sent by concerned field formations to Legal and Tribunal Cell (HQ), for filing miscellaneous petition before the Supreme Court/High Court/CESTAT for an early hearing, specifying the grounds clearly.

- 2. It should be ensured that the information pertaining to the cases filed before the Supreme Court, the High Court, the CESTAT and the Commissioner (Appeals), is separately maintained. The updated position of 'Appeal' cases should be retrieved periodically from the official website of the respective courts and also by contacting Superintendent, (Legal Co-ordination Cell), Mumbai. A separate register/database pertaining to the pre-deposits made by the parties during the filing of the appeals before various appellate forums is required to be maintained.
- 3. Register relating to the appeals pending at different levels should be maintained and abstracts drawn on a monthly basis and be inspected by the in charge D.C. /A.C. on monthly basis.
- 4. After adjudication, the matters where the orders are in favour of the Revenue should be forwarded to the Recovery Cell immediately for recovery of revenue, if the order is not appealed against.
- 5. It is emphasized that the instructions contained in the instant Standing Order should be followed strictly and any difficulty experienced should be brought to the notice of the undersigned or the respective section in charge.
- 6. All the officers of the Customs Commissionerate, Goa, are hereby directed to update themselves on the new procedure and revert in case of difficulties, if any.
